

## Privacy Policy

### 1. Introduction

Welcome to BetCartel (the “Site”, “we”, “us”, or “our”). We respect your privacy and are committed to protecting your personal information. This Privacy Policy explains what personal data we collect, how we use and store it, and your rights in relation to that data.

By using our Site, or by subscribing to our newsletter or confirming age/terms, you agree to the practices described in this policy.

### 2. What data we collect

We collect only the following personal data from our users:

- **Email address** — when you subscribe to our newsletter.
- **Age verification / acceptance confirmation** — when you confirm that you meet minimum age requirements and accept our terms and conditions (e.g., acknowledgement of outside-Hungary terms).

We do **not** collect sensitive personal data (e.g., health, race, political opinions) or other personal identifiers unless explicitly requested and consented.

### 3. How we collect the data

- Newsletter subscription form: when you voluntarily enter your email and submit.
- Age/terms confirmation checkbox: when you explicitly confirm on the Site’s age-verification or terms-acceptance prompt.
- We do **not** collect personal data automatically (e.g., we do not tie email to IP by default, track behavior, or require registration beyond optional newsletter).

### 4. Purpose of data collection & lawful basis

We collect and process your personal data for the following purposes:

- To send you our newsletter, containing updates, information, and promotions relating to online casinos and related content — **lawful basis**: your explicit consent (you opted in).
- To verify that you meet age or other eligibility requirements (e.g., that you are of legal age) and that you acknowledge any relevant terms — **lawful basis**: compliance and legitimate interest to ensure responsible operation.

We do **not** use your data for profiling, targeted advertising, or sale to third parties.

### 5. Data Retention

We will keep your email address only as long as:

- You remain subscribed to the newsletter, or
- You have not requested deletion.

If you choose to unsubscribe (for example through an “unsubscribe” link in a newsletter email), your email address will be deleted from our active mailing list. We may keep

anonymized or aggregated data for statistical purposes, but no personal identifiers will remain.

## **6. Data Security**

We take appropriate technical and organizational measures to protect your personal information against unauthorized access, disclosure, alteration or destruction.

For example: secure handling of subscriber lists; restricted access; appropriate data storage; email-sending via secure systems.

However, as with all internet-based communications, no method of transmission or storage can guarantee 100% security.

## **7. Your Rights**

Depending on your jurisdiction (e.g. EU), you may have certain rights regarding your personal data. These may include:

- The right to request access to the personal data we hold about you.
- The right to request correction or deletion of your personal data.
- The right to withdraw your consent at any time (e.g. unsubscribe from newsletter).
- The right to lodge a complaint with a supervisory data protection authority, if you believe your rights are violated.

## **8. Children's Data**

Our Site is not intended for individuals under the legal gambling age applicable in their jurisdiction. We do not knowingly collect personal data from minors. By using our Site and confirming age verification, you declare that you are of legal age.
