

Terms of Service

1. Introduction & Scope

Welcome to **BetCartel** (the “Site”, “we”, “us”, or “our”). These Terms of Service (“Terms”) govern your access to and use of the Site, as well as any content, functionality, and services offered on or through the Site.

By using or accessing the Site, you agree to be bound by these Terms, including any modifications made over time. If you do not agree to these Terms, you must not use or access the Site.

Important restriction: Access to this Site is strictly prohibited for persons who are located in or residents of Hungary. By entering the Site you confirm that you are not based in Hungary and that your access and use of the Site is legal in your jurisdiction.

2. Acceptance of Terms

- Use of the Site constitutes your acceptance of these Terms.
- We reserve the right to modify, update or replace these Terms at any time. Notice of changes will be posted on the Site. Continued use of the Site after such changes will constitute acceptance of the new Terms.

 - Use any automated means (bots, scrapers) to access or collect data from the Site without our express permission.
